Both trees cause a health and safety risk to the public, it is also highly likley that the tree will damage the property of 25 warehouse hill at some point in near future as they are so close to the property.

Ash (T1) - Tree A - Removal of tree due to Ash dieback present throughout tree. Tree drops large branches regularly onto property with potential damage to building and vehicles, The tree also overhangs a busy road where health and safety is at risk when larger branches are falling. Advise from tree surgeon is tree isn't in good enough state to be repaired and needs removing.

Ash (T1) - Tree B - Removal of tree due to Ash dieback present throughout tree. Tree drops large branches regularly onto property with potential damage to building, The tree also overhangs busy canal where health and safety is at risk when larger branches are falling. Advise from tree surgeon is tree isn't in good enough state to be repaired and needs removing.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
