I wish to object to the proposed quarrying activities at Bromley Farm Quarry. It will be detrimental to the locality for the following reasons: The proposed development would have a major impact on the natural environment. The most immediate impact is on the agricultural land use which would destroy animal, insect and plant habitats. Less than half a mile away are the Upper Dearne Woodlands, a conservation area home for a variety of wildlife including bats, badgers, deer, woodpeckers, owls and a variety of other animal and birds. This natural environment will be greatly affected by such a development right on its doorstep. What may have been acceptable when planning permission was granted for the original quarry many years ago is not acceptable today where effects on the natural environment should be granted a far greater say in decisions such as this. The application document almost ignores the effect on the environment in this semi rural area the development which would be very much out of keeping with the rest of the area creating a visible eyesore. In terms of noise, disturbance and pollution the plans suggest that there would be a HGV entering or leaving the site every six minutes. This is my interpretation. The exact numbers though are very unclear and must cast doubt on whether Wavin are able to clarify EXACTLY the vehicle numbers involved. I note also the hours of work. 7.30am to 6pm on Monday to Fridays and 7am to 1am on Saturdays. These hours are too long with noise pollution a great concern from our house only 75metres from the entrance to the site from A635 entrance. Also this will be even earlier on a Saturday. So we will be woken up at 7.30 by noisy wagons in the week and have no chance of a lie in on a Saturday. I also note the use of the existing entrance to the Council tip off A635. This is barely wide enough for two cars to pass. When HGVs at the rate of one every 6 minutes use the site as well as the cars visiting the tip this will lead to traffic congestion as well as noise. This is especially so on Saturday morning, the busiest time at the tip. Why is the narrow road leading to the quarry to be the width of 2 HGVs? Wavin clearly recognise	

spur road leading to the quarry to be the width of 2 HGV's? wavin clearly recognise access will be a problem when making this road such a width with no alteration in the existing tip road. More planning permission required?

Landfill Gas potential as suggested in the report of Enviro AG which may lead to explosions

Mine Gas potential as suggested by the Coal Authority report which may lead to explosions and toxic gas release.

The general affect on local traffic in particular the ease with which we can exit Greenwood Farm Lane onto the A635, the added congestion at the Sovereign crossroads and Carr Hill Road which is already a serious problem. In my experience Wavin lorries do not use existing A roads to deliver to Crow Edge They take the shortest route possible be that B roads or smaller. This will only get worse.

Noise Pollution both in the quarry and on local roads.

Dust pollution, clay and shale are known to be very dusty Regardless of any safeguards Wavin may suggest dust will undoubtedly increase.

The affects of all the above on the local primary school only yards from the quarry

The detrimental affect on local house prices. Can Wavin compensate using the profits they will make as a result of the proposal?

With all the affects I have stated above I believe the Council should decline the application. There is no benefit for the community to live alongside the dirt, noise, pollution and disturbance as well as the enviromental devastation the site is due to cause for the next 25 years Crucial to my objection is that the development will safeguard zero jobs in Kirklees. Absolutely none. Wavin Hazlehead has the following postcode S36 4HG, a South Yorkshire not a Kirkless postcode.
