Why do you consider that a Lawful Development Certificate should be granted for this proposal?

Proposals are for the construction of a Dormer to the rear of the existing property compliant with Permitted Development Guidance set out within the Permitted development rights for householders: technical guidance - Class B Development – Additions to the roof of a house and House Extensions and Alterations SPD.

- The total cubic area created by the new dormer does not exceed 50 cubic metres of additional roof space. The property is a semi-detached house.
- The new dormer is to the rear of the property and does not sit beyond the plane of the existing roof slope of the principal elevation that fronts the highway.
- The new dormer is not higher than the highest part of the roof.
- The materials are similar in appearance to the existing house.
- There are no verandas, balconies or raised platforms.
- There are no side-facing windows.
- The property is not on article 2(3) land – conservation area, AONB, Broads
- The dormer is set back 20cm from the original eaves.
- The dormer does not overhang the outer face of the wall of the original house.
