## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The work will be done on the large Sycamore tree on the boundary between 328 and 330 Wakefield Road. This is the front of the properties on the Wakefield Road side. The tree is mid-way up the gardens and its situated in the hedge. We propose to remove some of the height by lopping the top branches to allow some light into our garden. We will take advice on how much to take off, but we think 2 meters should be OK. There are also some branches which snag the telephone cable, so we'd like to shorten them.

There are rooks nesting this year so we would wait until December.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
