An Acer Pseudoplatanus (Sycamore), 22m (S5), was inspected by Kirklees Council Forestry Department on 11/05/23 and findings recorded in the Ezytreev database, tree code 582028 site tree number 69.

This tree was displaying signs of decline at the last inspection in July 2022 with bark loss and evidence of fruiting bodies around the roots. Further deterioration has occurred in the last 10 months with bark loss now extensive and bootlaces extending up the stem making it unsafe to retain given its location by a busy footpath within a heavily used public open space. It is proposed to fell to ground level to ensure public safety. No replant is proposed in order to allow space in the canopy for the Ulmus Glabra (Wych Elm) already in place to develop to maturity.
