

Additional Sheet

Tree A (1) is a Holly Tree, which after 45 years of growth is now as tall as the telegraph pole which it was planted next to, and is now almost touching the telephone line. A fair portion of the tree overhangs our boundary.

Tree B (2) is a weeping Silver Birch which was originally planted on the boundary line between our two houses, but the trunk has grown on our side and branches now extend to some 15 feet over our garden.

My request is with the full approval of our neighbours family.

My request is that the height of the Holly tree is reduced by, say, 50% and the overhanging branches on our side are reduced.

The overhanging branches of the weeping Silver Birch tree to be cut back, or, ideally, remove the whole tree
