Following the updates to Approved Documents F,L,O & S coming into effect in June 2022, Keepmoat has updated its 2018 house type range to a new 2022 house type range. All house types receive a new name, but the internal layout does not change. This 2022 range receives a new specification that complies with the new requirements, for example, lower minimum U values, 31% CO2 emissions reduction, PV to all plots and a lower maximum air tightness target.
