G5 Mixed deciduous See Observations Six Hollies, two Cotoneasters and a Birch. Birch being suppressed by the Hollies and the Birch has a Phytophthora species infection. Vegetation low over neighbouring path/s. Remove; fell and treat the Birch tree. Crown lift the remaining vegetation to 2.5 metres. No replacement as tree is within a relatively compact group and removal will provide space for the remaining trees.

T1 Common Beech Vertical main stem and spreading crown. Low branches over garden areas. Branches touching/close to buildings. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance.

T11 Common Beech Vertical main stem and spreading crown. Low branches over garden areas. Branches touching/close to buildings. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance.

T14 Horse Chestnut Vertical main stem and spreading crown. Branch ends touching buildings. Branches extending well over neighbours and low down. Old bacterial canker lesions noted on main stem. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance (both sides).

T15 Sycamore Vertical main stem and spreading crown. Branch ends near to building. Epicormic growth. Ivy on main stem. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance. Remove epicormic growth around basal area.

T16 Sycamore Vertical main stem and spreading crown. Branches overhang neighbouring property. Cut back overhang to fence line and crown lift 3 metres.

T17 Sycamore Vertical main stem and spreading crown. Cavity in base to north side. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance. Remove epicormic growth around basal area.

T18 Horse Chestnut Vertical main stem and spreading crown. Branch ends against building. Crown lift 3 metres. Cut back from building/s to leave 3 metres clearance (both sides).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
