- Please note a Tree Survey has been completed by JCA which is attached with the recommended work.
- (T1) Semi-mature Sycamore, overhangs the boundary and neighbouring garage. Prune to provide a 3m clearance from the neighbouring garage. Deadwood and pruning stubs.
 - (T2) Early-mature Chestnut, slightly unbalance crown which overhangs the boundary and neighbouring garage. Bleeding of the canker of horse chestnut noted. There was a small split in the stem. Prune to provide a 3m clearance from the neighbouring garage.
 - (G3) Young Mixed Species, strim brambles and other herbeceous vegetation.
 - (T4) Semi Mature Lime, slightly unbalanced crown which overhangs the boundary. Clear epicormic growth from the stem to a height of 3m. Crown lift the canopy over the boundary to 4m. Ensure the neighbouring tree has a clearance of at least 1.5m to secondary branches

7. Identification Of Tree(s) And Description Of Works continued ...

Please read attached survey from JCA with the recommended work.

- (T5) Lime, leaning with a balanced crown which overhangs the boundary. Clear epicormic growth from the stem to a height of 3m. Crown lift the canopy over the boundary to 4m.
- (T6) Lime, Leaning with a balanced crown which overhangs the boundary and a neighbouring tree. Ideally remove the neighbours raised bed from the base of the tree. Cut the metal bar free and make safe if possible.
- (T7) Sycamore, Vertical slightly unbalanced crown which overhangs the boundary and is overgrowing neighbouring Leyland Cypress. Clear the ivy from the stem. Crown lift the canopy over the boundary to 4m. Ensure the neighbouring tree has a clearance of 1.5m to branches.
- (T8) Lime, Leaning with a kink. There is an overextended limb overhanging the garden of the subject property. A decay wound is noted to this branch. There is appropriate pruning point in line with the fence. Prune overextended branch to union over the fence. Clear epicormic growth.
- (T9) Sycamore, vertical with an unbalanced crown which overhangs the boundary and a shed. It is occluding the fence. A tight union is noted. Prune to provide 2m clearance from shed to secondary branches provide 1.5m clearance to neighbouring tree from branches.
- (T10) Horse Chestnut, slightly unbalanced crown which overhangs the boundary. Loose bark is noted around 3m, likely from Bleeding Canker of Horse Chestnut. Spike wounds noted from previous work. Prune clean off any stubs as best as possible.
