Details of the pre-application advice received

We sent across proposals for a much larger building and Link Extension initially. It was agreed that Annex Buildings are acceptable but the height needed to be reduced. This proposal reduces the new building considerably and makes it subservient to the Host Building as requested whilst the design compliments the Principal Building. The proposals do not have an overbearing or visual impact on the Host Building, of which was an initial concern with the original design.
