Mature Horse Chestnut Tree. To Fell.
The tree has had Horse Chestnut Bleeding Canker for many years according to the owner and also suffers from Leaf Miner. The tree also sheds immature conkers in spring and early summer.

To Fell, because there is clear evidence that the tree is shedding branches due to the canker. The arborist has identified areas within the canopy where there are large dead branches and weakened branches. One large branch over Hand Bank Lane is identified as in need of urgent attention. Evidence is given of a very large branch fall some years ago. No one was injured on that occasion.

7. Identification Of Tree(s) And Description Of Works continued ...

In addition to the risks to the Garden office under the canopy at 1C Hopton Lane, there are some 13 properties higher up Hand Bank Lane which produce a fair number of pedestrian and vehicle traffic each day, including deliveries and utilities traveling under the tree. A public footpath also passes under the canopy along the lower part of Hand Bank Lane.

The Stone boundary wall, 1500mm high, between the owners property and Hand Bank Lane is in danger of collapse into the lane, due to the growth of the trunk. (see photograph in report)

The canopy extends over the lane and will soon be over the roof of Hand Bank House, a dwelling opposite the tree ,which will increase the risks to that property and residents.

At this time of the year, before the Leaf Miner turns the leaves prematurely brown, the spring leaf growth hides the risks identified above and in the arborist's report. in July The great majority of the leaves are brown and curling

This tree (T8) is in what was originally the garden area of Brooklands House. A few years ago an identical Horse Chestnut TPO ID: 02/03/T7 adjacent to Brooklands House, most likely planted at the same time from the same stock as (T8), had to be felled as dangerous.

The tree should be felled safely in accordance with guidance from AFAG and be replaced with an appropriate Sycamore Maple tree.
