## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

There are three areas on the golf course where TPO trees are causing issues with the playability of the course.

1. Right hand side of the 8th hole. This area is owned by the Longwood conservation group and the area is known as pig wood hill. We would like to ask permission to prune back the trees that are overhanging the wood/course boundary. I have spoken to owners of the land and they are happy for the golf club to prune the trees as long as we do not remove any trees. It is not the clubs intention to remove any trees. The boundary is approx. 150 yards long and trees are overhanging along the entire length.
2. Left hand side of 10th hole near the tee box. Again these trees are covered by a TPO , but these trees are owned by the golf club. The club are happy for these trees to be pruned. These trees are not overhanging a boundary, but the growth is now forcing players to aim further right than intended and are therefore aiming towards a putting green on a seperate hole. this is a H&S issue. Our ask is to prune these trees back so the hole can be played as intended.
3. There is one single tree by the 8th tee box that we would like some clarity on the status of any TPO. It is right on the boundary of the TPO area. We would like to remove this tree, but want to check first. The tree is growing next to a dry stone wall that runs along side a public footpath. The tree is causing the wall to move and bow. Ideally we would like to totally remove this tree but want to seek advice first.

I have walked the areas with two different trees surgeons to get an idea of what is possible subject to this application. Both surgeons thought the best next step to be walk the areas with right person from the council who could advice on if the work would be allowed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
