We have just bought a property which has 2 protected trees (UPRN 83039958). We would like to complete a crown lift and a crown reduction on 1 silver birch and 1 copper birch tree. The trees are very close to the boundary line and are currently overhanging the pedestrian pathway. The works would provide access to people/pedestrians using the footpath.

On the property there are four very large conifer trees which have been left to become very over grown. These trees are now touching the house, interfering with the power cables/telephone lines which are attached to the house. These trees are stopping the growth of the cherry trees and other shrubs within the garden. The conifer branches have a very large spread and are subsequently reaching/spreading out very close to the boundary of our neighbour.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

To remove the five conifer trees so we can allow the other trees and bushes to thrive. There are two cherry trees which are struggling to thrive due to the lack of space. We would also like to prevent the conifer trees from touching the house and interfering with power lines for both our property and the property of our new neighbour (Number 40). We plan to replant in the area where the conifers currently are, with more appropriately sized plants and bushes.

We would like to complete a crown lift and a crown reduction of the silver birch and the copper birch by 30% so they do not over hang and obstruct the public footpath (UPRN83039958). Also we would like to give them some shape and care for them.

We would like to prune the cherry trees to encourage growth as they are very tall and thin as the conifer trees are taking up a lot of space and light in the garden as the conifers have been neglected for a number of years.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
