Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

.Lopping of tree, in back garden on 50 west park street. Stom damaged and broke off main branch(1 of 2), of the trunk of tree.

Remaining branch of tree(2 of 2), needs reducing/cutting back/lopping.

Hanging over garages of my mothers property and neighboring property.

Branch (2 of 2) leaning more over neighboring property.

Branch (2 of 2) has 6 main arms.

1 and 2 of the 6 arms are hanging over our property.

3 to 6 of the 6 arms, over hanging the neighboring garage and road. The road is a maintained council road with street lights, used by about 15 properties.

Possible damage to properties and blocking of road with further storms and adverse weather.

Liability for this would be on is the owners of the tree. Required permission to:

1. Cut back over hanging arms of branch (2 of 2)
2. Make branch (2 of 2) less possible to be swayed by hard/srong winds.
3. Keep tree trunk and remaining branch (2 of 2).

Only tree: Sycamore tree.

Tree height over 10 meters.

Crown reduction 6 arms off branch remining. Covering about 4 meters height from top.

Width - over two properties and road.

Proposed cutting the other maon branch or lopping of the few (6+) arms off the branch.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
