The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INSTALLATION OF REPLACEMENT
FRONT WINDOWS (WITHIN A CONSERVATION AREA)

At: 12, PARKWOOD ROAD, LONGWOOD, HUDDERSFIELD, HD3 4TT

In accordance with the plan(s) and applications submitted to the Council on 31-Oct-2023 subject to the condition(s) specified hereunder:-

1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion, in the interests of the significance of the heritage assets, including Longwood Edge Conservation Area, and to accord with Policies LP1, LP2, LP24 and LP35 of the Kirklees Local Plan, as well as Chapters 2, 12 and 16 of the National Planning Policy Framework.

3. Notwithstanding the details provided, new windows shall be timber framed fixed light or side hung casements with a white or off-white painted finish, with chamfered glazing beads. All double-glazed units shall be slim in section, with 4mm glass and an 8mm gap with black spacer bars. Opening casements shall be set flush with the frames with butt hinges and traditional window stays (friction hinges and visible trickle vents shall not be permitted) and all new window frames shall be set back in the reveal by 75-100mm and not fitted flush with the external wall. The windows hereby approved shall thereafter be retained.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

FOOTNOTE: There shall be no use of filler or expandable foams in any part of the works, including the fitting of the replacement windows.
