Daniel Atkinson visited on November 1st and inspected trees in our garden. 2 Ash trees near retaining wall and agreed that both trees can be cut down due to leaning over the main road and falling branches. There are two sycamores on the banking and one is a risk as stated by a tree specialist Michael Palmer Equinox trees. There is a lot of water gathers around the base of the trunk and many roots exposed. The banking has moved and the tree has not been good this year in terms of leaves being green but more dry and withered. Earlier this year Nick Goddard looked at the trees and asked that we monitor this tree and if leaves were yellowish we should contact him and he would take necessary action stating that the council are fully responsible and liable if the trees should fall or lose branches. I am requesting that we remove 4 trees as seen by Mr Atkinson today 01/11/2023. My reasons and concerns are as follows: I fear that with each storm and such a lot of rain that these trees are a high risk of falling and causing catastrophic damage and risk to life and surrounding properties. I cannot rest or ease my concerns b

Because I I fear more for my neighbours than myself. The trees are with very close proximity to our house and neighbours houses and I worry. My concerns are real and not unjustified certainty not to me or my husband. The trees sit precariously on banking that is moving and pulling downward and as I live here I see this all the time. Mr Atkinson also found that another tree had a long wound and work could b3 done on that too. I would like to end my worries and have the trees cut down to avoid a disaster in waiting. In the past we have contracted councillor Armer to help with our application. There's rot on on the other sycamore and we were advised to keep an eye on that and that all adds to my concerns. I feel that this needs action and an outcome to allay our fears and constant worrying that the trees will uproot or lose big branches as they are a huge risk of harming us and property. I shall keep applying and appeal if necessary as we want to feel safe in our home and garden and rest easy without this constant headache regarding these trees.
