PLANNING PERMISSION FOR DEVELOPMENT

In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby permits:-

**ERECTION OF DORMER EXTENSIONS TO CREATE FIRST FLOOR LIVING
ACCOMMODATION, ALTERATIONS TO FENESTRATION TO REAR ELEVATION,
ERECTION OF BALCONY AND ALTERATIONS TO EXTERNAL STAIRCASE**

At: SYCAMORE LODGE, 41, BROAD LANE, UPPERTHONG, HOLMFIRTH, HD9
3XE

In accordance with the plan(s), documents and application submitted to the Council on 23-Nov-2023, except as amended or specified, details of which can be found in the table below and subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 91 of the Town and Country Planning Act 1990.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies LP1, LP2, LP21, LP22 & LP24 of the Kirklees Local Plan, Principles 1, 2, 3, 4, 5, 6, 7 and 15 of the Council's adopted House Extensions and Alterations SPD, Policies 1, 2 and 12 of the Holme Valley Neighbourhood Plan, and policies within Chapters 2, 12 and 14 of the National Planning Policy Framework.

3. The materials of construction used in the works to alter the roof hereby approved shall be dark grey roof tiles to the roof and timber cladding to the gable end elevations of the host property. The materials of construction shall thereafter be retained.

Reason: In the interests of visual amenity and to accord with Policy LP24 of the Kirklees Local Plan, policies within Chapter 12 of the National Planning Policy Framework, Principles 1 and 2 of the House Extensions and Alterations Supplementary Planning Document and Policies 1 and 2 of the Holme Valley Neighbourhood Development Plan.

4. The hereby approved dormers shall be finished in aluminium cladding, of a dark grey colour finish. The materials of construction and colour finish shall thereafter be retained.

Reason: In the interests of visual amenity and to accord with Policy LP24 of the Kirklees Local Plan, policies within Chapter 12 of the National Planning Policy Framework, Principles 1 and 2 of the House Extensions and Alterations Supplementary Planning Document and Policies 1 and 2 of the Holme Valley Neighbourhood Development Plan.

5. The balcony shall not be brought into use until an opaque glazed screens to 'Level 3' obscurity has been placed on both side elevations of the balcony, as shown on Dwg No.'s 230426-P-A204 Rev C, 230426-P-A205 Rev C and 230426-P-A207. The opaque glazed screens shall thereafter be retained.

Reason: In the interests of the amenity of neighbouring properties in relation to overlooking to accord with Policy LP24 of the Kirklees Local Plan, Key Design Principles 3 and 4 of the House Extensions and Alterations SPD, Policy 2 of the Holme Valley Neighbourhood Development Plan and the policies contained within Chapter 12 of the National Planning Policy Framework.

Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- As this is a decision for a householder application, if you want to appeal against your Local Planning Authority's decision to impose planning conditions then you must do so within 6 months of the date of this notice.
- If an enforcement notice is served or has been served relating to the same or substantially the same land and development as in your application and if you want to appeal against the local planning authority's decision on your application, then you must do so within 28 days of the date of service of the enforcement notice.

- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN (Tel: 0303 444 5000) or online at <https://www.gov.uk/appeal-householder-planning-decision> . - You must use the correct Planning Appeal Form when making your appeal. If requesting forms from the Planning Inspectorate, please state the type of application that the appeal relates to so they can send you the appeal form you require.
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to him that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.

Purchase Notices

- If either the local planning authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that the owner can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.

In these circumstances, the owner may serve a purchase notice on the Council. This notice will require the Council to purchase the owner's interest in the land in accordance with the provisions of Chapter I of Part VI of the Town and Country Planning Act 1990.
