Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The following are located in front of block 46-53.

DEC1 = Deciduous group. Remove all cotoneaster shrubs growing up and between the mature trees found in the group, they are inhibiting the better species in this small space. A1= multi stemmed Ash sapling, remove to ground level. SY1 = Sycamore sapling, remove to ground level. A2 = Ash sapling, remove to ground level. SUC1 = Sucker growth group, a mixture of Chestnut, Ash, Sycamore sucker growth, remove to ground level and poison/grind the stumps.

The following are located in front/side of block 16-20.

CH1 = Chestnut species, crown lift to 5.2m over the road and to 3m over the carpark bays. CO1 = Conifer hedge. Reduce this down in height to make it 6 foot in height, measuring from the ground. CO2 = Conifer, small conifer to remove to ground level. MA1 = Maple species reduce away from building giving a 2-3m clearance.

The following are located next to block 33-38.

BUD1 = Buddleia, reduce down to 4ft in height to make it easier to maintain in the future. SY2 = Sycamore species, remove epicormic growth which is 2m from ground level, reduce away from building giving a 2-3m clearance. This Sycamore is found within a Cotoneaster shrub, which will be getting reduced in height and width to make it easier to manage in the future. this will also allow for better inspection of the base of the tree.

The following are located next to block 26-32.

PI1 = Pine species, remove dead pine to ground level. OA1 = Oak species, remove to ground level as it is in a poor position.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
