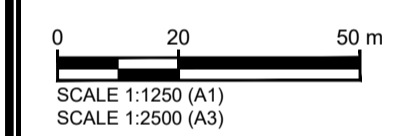

 - DIVERSION TO EXISTING PROW REQUIRED TO FACILITATE CONSTRUCTION OF NEW WETLANDS.
 - NEW FOOTPATH TO FOLLOW EXISTING SOUTHERN BOUNDARY OF THE FIELD, MIN 8m FROM THE BANKS OF THE RIVER DEARNE.
 - NEW PATHWAY TO BE 2m WIDE WITHIN A 3m CORRIDOR, SEPARATED FROM THE NEW WETLANDS VIA TIMBER POSTS AND STOCK WIRE FENCING TO MATCH EXISTING SOUTHERN BOUNDARY. ANY GAPS, GATES AND STILES TO BE MODIFIED OR CREATED TO BE AS PER BS 5709 (2018).
 - PATHWAY TO BE FORMED OF SUB BASE COMPOSING 100mm TYPE 1 WITH A GEOTEXTILE (DUG INTO EXISTING GROUND LEVEL) UNDERLAY BY 100mm CRUSHED SANDSTONE 1:50 CROSSFALL OF PATH (RUNNING TOWARDS THE WETLANDS). 100mm SEMI-PERFORATED DRAINAGE TO RUN ADJACENT TO FENCE BORDERING WETLANDS WITH CROSS DRAINS EVERY 50m DISCHARGING INTO THE RIVER.
 - ANY OVERHANGING TREES ABOVE THE NEW PROW ARE TO BE PRUNED BACK FOLLOWING ECOLOGICAL ASSESSMENT. ANY TREE WITH POTENTIAL TO CAUSE DAMAGE/INJURY TO USERS TO ALSO BE ASSESSED PRIOR TO ANY PARTIAL FELLING.
