T1434 - Horse Chestnut - Remove lowest 1m of Ivy from trunk (causing no damage to trunk). Reduce crown back from street lights to give 1m clearance through full height and ensure down light is not obstructed when tree is in leaf.

T1439 - Elder - Remove self set Elder that is leaning on the wall with a low crown obstructing the footpath, to abate foreseeable nuisance.

Cypress 01 - Leyland Cypress - Fell to near ground level as tree has out grown its location and is blocking light and view from bay windows.

Cypress 02 - Leyland Cypress - Fell to near ground level as tree has out grown its location and is blocking light and view from bay windows.

Group 1 - Mixed Species - Crown lift to 3m over the garden for pedestrian clearance & crown lift to 5.2m over the road for vehicle clearance.

Group 4 - Mixed Species - Crown lift to 5.2m over driveway for vehicle clearance.

Group 6 - Cherry - Remove Cherry leaning on overhead BT cables.

Group 7 - Mixed Species - Crown lift to 5.2m over driveway for vehicle clearance.

T0628 - Horse Chestnut - Crown lift to 5.2m over the road for vehicle clearance.

T1862 - Oak - Remove deadwood exceeding 50mm in diameter and/or 1m in length.

T1864 - Elm - Fell dead Elm to near ground level.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
