Details of the pre-application advice received

In conclusion, on the basis of the information that I have before me, the proposed development could not be supported. It is considered that the principle of development could be acceptable, however there are concerns to the proposal regarding the impact on visual amenity, as a combined result of the linear form, contemporary design and volume of proposed copper cladding. As part of any future application, consideration should be given to reducing the footprint and height of the dwelling so that it does not exceed the scale previously approved and amending the form and design to reduce the scale and massing and introduce a more subservient element. Comments made in this response should also be taken into account in relation to the design of the dwelling and use of materials and any contemporary design should be clearly justified and it demonstrated that it would be appropriate within the site context. The full extent of any excavation/levelling works should also be shown as part of any planning application.

A Heritage Impact Assessment is required as part of any future planning application to demonstrate that the development would not harm the setting of the adjacent Conservation Area and Listed Building. Further information is also required with regards to highway safety, trees and the Public Right of Way footpath as set out within this response.
