Assessment

Permission is sought for the erection of a porch.

The measurements of the porch would be as follows:

- ~2 metre projection
- ~2.7 metre width
- ~2.5 metre eave height
- ~3.3 metre ridge height

The proposed construction materials are natural stone for the walls with concrete tiles for the lean-to roof.

There would be one Velux rooflight as well as one window within the south-west facing elevation.

The porch would be located to along the principal elevation of this single aspect property, but does not front a highway.

The Kirklees SPD sets out that front extensions should comply with certain parameters set out at paragraph 5.14 on page 27 (and listed below) and if they do not, they need to be justified:

Design and Visual Amenity: Are the considerations in the following table acceptable?

Summary of local street scene/character:

21, Woodhead Road is an 'end-terrace' property within a block of dwellings located in Lockwood. Adjoined properties are constructed using natural stone with concrete tile roofs. The property is set ~2.5 metres back from the roadside with boundary treatments consisting of low stone walls with mature hedging.

To the side (south-west facing) elevation is a row of six terraces constructed from brick. These dwellings are located at a higher ground level than the application site and are positioned ~7 metres from the roadside, causing their rear elevation to be set back from No.21.

Consideration has been given here in terms of the proposals impact on the local character and street scene, including subservience, terracing and building line.

Residential Amenity: Are the considerations in the following table acceptable?

The main properties affected are:

11, Woodhead Road – adjoined neighbour from north-east facing elevation

It is not considered that the proposed works would cause detrimental harm to the residential amenities of this neighbour. The porch would be set ~3 metres off the shared boundary with blank elevation facing this neighbour, therefore would not be detrimental in terms of overlooking/overbearing/ loss of privacy.

23, Woodhead Road – located south of the application property

This property is set slightly behind the application property, and at a higher ground level, it is not considered that the porch extension would cause detrimental harm to overshadowing/overbearing/ loss of privacy.

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to the requirements of Section 91 of the Town and Country Planning Act 1990.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to accord with Policies LP01, LP02, LP21, LP22 & LP24 of the Kirklees Local Plan, Principles 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 & 15 of the Council's adopted House Extensions & Alterations Supplementary Planning Document and Policies within Chapters 2, 9, 12 and 14 of the National Planning Policy Framework

3. The external walls and roofing materials of the extension hereby approved shall in all respects match those used in the construction of the existing building.

Reason: In the interests of visual amenity and in accordance with Policies LP01, LP02 & LP24 of the Kirklees Local Plan, Principles 1 and 2 the Council's adopted House Extensions and Alterations Supplementary Planning Document and policies within Chapter 12 of the National Planning Policy Framework.

NOTE: Due to its location, a bat roost may be present on site. Bats are a European protected species under regulation 41 of the Conservation of Habitats and Species Regulations 2010. It is an offence for anyone intentionally to kill, injure or handle a bat, disturb a roosting bat, or sell or offer a bat for sale without a licence. It is also an offence to damage, destroy or obstruct access to any place used by bats for shelter, whether they are present or not. If bats are discovered on site development shall cease and the applicant is advised to contact Natural England for advice.
