The applicant wishes to vary the conditions as the tender prices for the sash windows came back 100% over budget due the complexity / cost per window of sash windows and the number originally indicated on the original application.

Condition 2 - we seek to vary the approved drawing referred to - elevation drawing 3536 (0-) 05 Rev C showed the majority of window openings as sliding sash. We would like to substitute the drawing with 3536 (0-) 05 Rev D. This incorporates the following amendment: Removal of stone finials. Reduction to sliding sash window to North and West elevation of the main house house and to the new conservatory. Replacing the sashes with a combination of fixed and casement windows with a horizontal glazing bar to replicate sliding sash windows as indicated on the revised elevations.

Condition 3 - we seek vary this condition as it was previously agreed by email from Kirklees Planning Officer Tom Hunt to One17AD on Wednesday 25th October 2023, which confirmed that Spiral/Spring Balance mechanisms were acceptable as long it was concealed as per drawing 3536 (0-) 06 Rev. B approved in the original application.
