Therefore, the application seeks approval of a replan of plots 39-44, 79-90, 132-133, 148-160 and 165-167. The main structure of the layout isn't altered by the changes and there is no reduction in number of plots or bedroom number mix already approved. All house types proposed are approved elsewhere on site except for the Spey which replaced the maisonette type, it is the same style of house type however it has a slightly different footprint.
