Please note this application is to amend the existing approved application - Ref (2022/62/90502/E) as detailed below.

1) We would really like to extend the area of the existing dog exercise park from 0.7 acres to 1.7 acres. Full planning permission originally received on 5th August 2022. Ref (2022/62/90502/E). After running the operation for 7 months (over the winter months) and listening to the valuable feedback from our users we feel that the existing area is too small and would be more use to people if it was bigger. We have had over 800 bookings since we opened so we are keen to make sure that we continue to meet the needs of the local people. Thankfully we own all the surrounding land so making the area bigger will not be a problem. We also think that the land will take less impact if the area was bigger, especially in the winter months. Finally all the surrounding dog exercise parks are approx 2 acres so if we can increase our space to 1.7 acres, this will ensure we can remain competitive.

2) We would also like to alter the surfacing of the existing car park from plastic grids with grass to recycled tarmac road planings because the existing surfacing doesn't work - see photos attached to the application. In the winter months it becomes extremely wet and muddy (zero grass visible) and so people park on the road because they think they will get stuck in the mud, which we absolutely do not want to happen. Altering the surfacing is predominantly a safety measure, however it will also improve the aesthetics of the car park. We have chosen recycled road planings because as a recycled aggregate, the use of road planings is considered environmentally friendly. Not only this but the main material of planings is often bitumen, a natural resource. The use of planings minimises waste and reduces the demand for alternative aggregates, such as quarried aggregates. We have also used recycled road planings for other entrances and roads on the farm and know it will work and be a much safer option for our users.

3) We would like to alter the proposed sliding gate in the car park to two swinging gates that meet and close in the middle. The proposed sliding gate is going to be very difficult to use and costly to build. Having 2 gates that meet and close in the middle will be much more simple for people to operate and produce the same outcome.
