Requested works:

T1 - maple: 10% crown thinning and removal of lower branches, to maintain light to house, maintain tree health and moderate tree size relative to house

T2 - ash: 10% crown thinning and removal of lower branches, to maintain light to house, maintain tree health, moderate tree size relative to house and allow closer inspection for signs of dieback

T3 - beech: 10% crown thinning and removal of lower branches, to maintain light to house, avoid branches overhanging house roof, maintain tree health and moderate tree size relative to house

T4 - ash: 10% crown thinning and removal of lower branches, to maintain light to house, maintain tree health, moderate tree size relative to house and allow closer inspection for signs of dieback; pruning of branches overhanging neighbour gardens

T5 - lime: Re-pollarding following previous pollarding work done before the house was sold to the current owners; pruning of branches overhanging neighbour gardens

T6 - beech: 10% crown thinning and removal of lower branches, to increase light to house, maintain tree health and moderate tree size relative to house; pruning of low branches overhanging neighbour gardens

T7 - lime: Re-pollarding following previous pollarding work done before the house was sold to the current owners

T8 - lime: Re-pollarding following previous pollarding work done before the house was sold to the current owners

T9 - lime: Re-pollarding following previous pollarding work done before the house was sold to the current owners

T19 - beech: 15% crown thinning and removal of lower branches, to maintain light to house, maintain tree health, moderate tree size relative to house, and reduce impact on neighbouring driveway

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
