Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree in question is a mature holly at the end of the drive of 21 Magdale, overhanging the drives of both 19 and 21 Magdale. Over the past 12 months the tree has shown signs of severe dieback with dropping of live growth, blackening of young growth and complete dieback of a substantial part of the canopy. This dieback has been confirmed by K Stephenson of Stephenson's Trees (Holmfirth). The tree is in the Magdale Conservation Area and I intend to remove it. It is identified in the attached sketch plan. I also attach photos showing the dieback in the canopy and the blackening of young growth at the base of the trunk. The holly in question currently obstructs a mature copper beech behind it. Removal of the holly will reveal the copper beech and improve its amenity value. The copper beech is one of three at 21 Magdale, the other being at the corresponding NE boundary of the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
