1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

This application is the resubmission of a previously permitted amended scheme for planning permission and Listed Building Consent which had extensive negotiations to ensure historic significance and amenity are adequately preserved or enhanced. The case officer considered the applications on review and, on discussion with the Conservation & Design Officer, agreed that the scheme had not been altered since and to seek no further amendments to the scheme for heritage amenity.
