Description of Proposed Works

Please describe the proposed works

This planning application is in support of a single-storey rear extension to the above property which has already been constructed. The property owners were under the impression that the extension was within permitted development so they only applied for Building Control Approval; Ref: 2023/EBN/00201/E.

The extension is single-storey with pitched roofs and a gable end. The extension is not the full width of the garden to allow for large amenity spaces to the rear and adjoining No. 16.

There is a gap to No. 20 with the roof pitching down to eaves level thus minimising any overshadowing impact on the amenity spaces serving this property. Refer to attached photos.

The property is over 11m from properties to the rear which front onto Longfield Road. Thus there is little or no visual impact on these properties from the new extension.

The property owner has consulted with the enforcement officer; Chris Cockroft who has advised submitting a planning application for the rear extension.

Just to note, the property is within an area where the permitted development rights have been removed but not for any extensions to the property. Thus a Larger Home Extension Application may have been possible for this property.

A very similar rear extension was approved for No. 19 Longfield Court in 2020; Planning Ref: 2020/692/91929.
