T1449 - Lime - Crown lift to 5m over neighbouring garden to provide clearance.

Shrubs and trees around north eastern side of garden – mixed species – Holly, Laurel, Elm, Sycamore - Cut trees/shrubs that are growing from Elysium healthcare back to behind Elysium Healthcare boundary stream. Up to approximately 5m to clear the water.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
