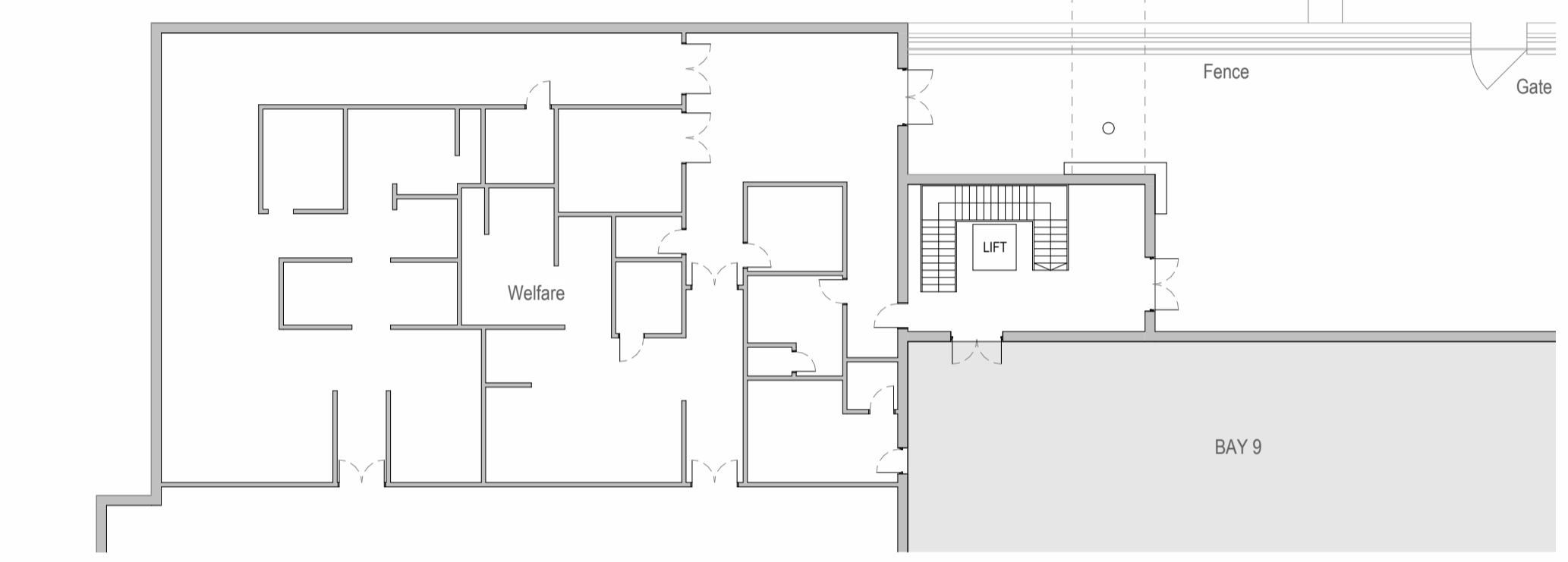
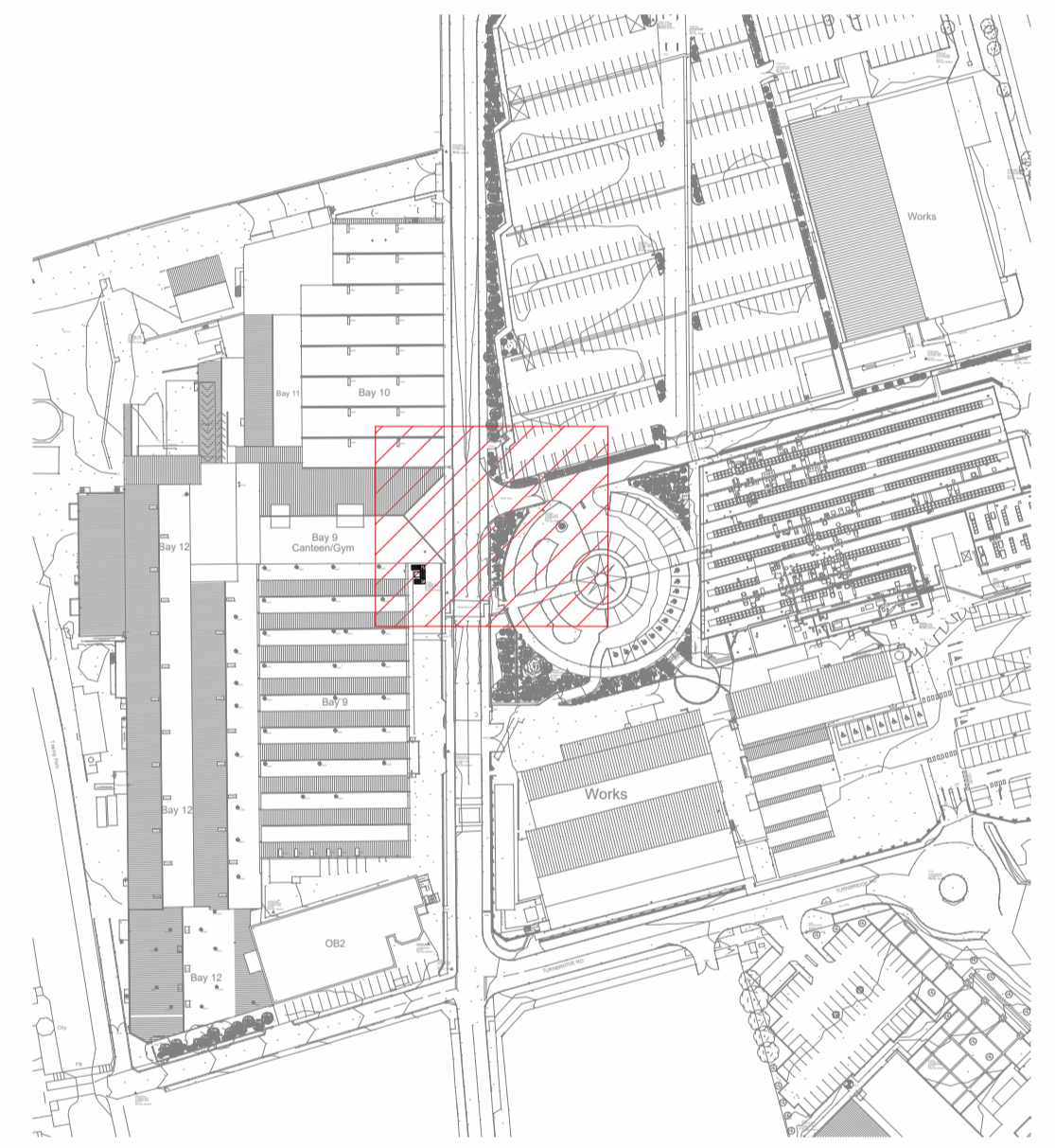


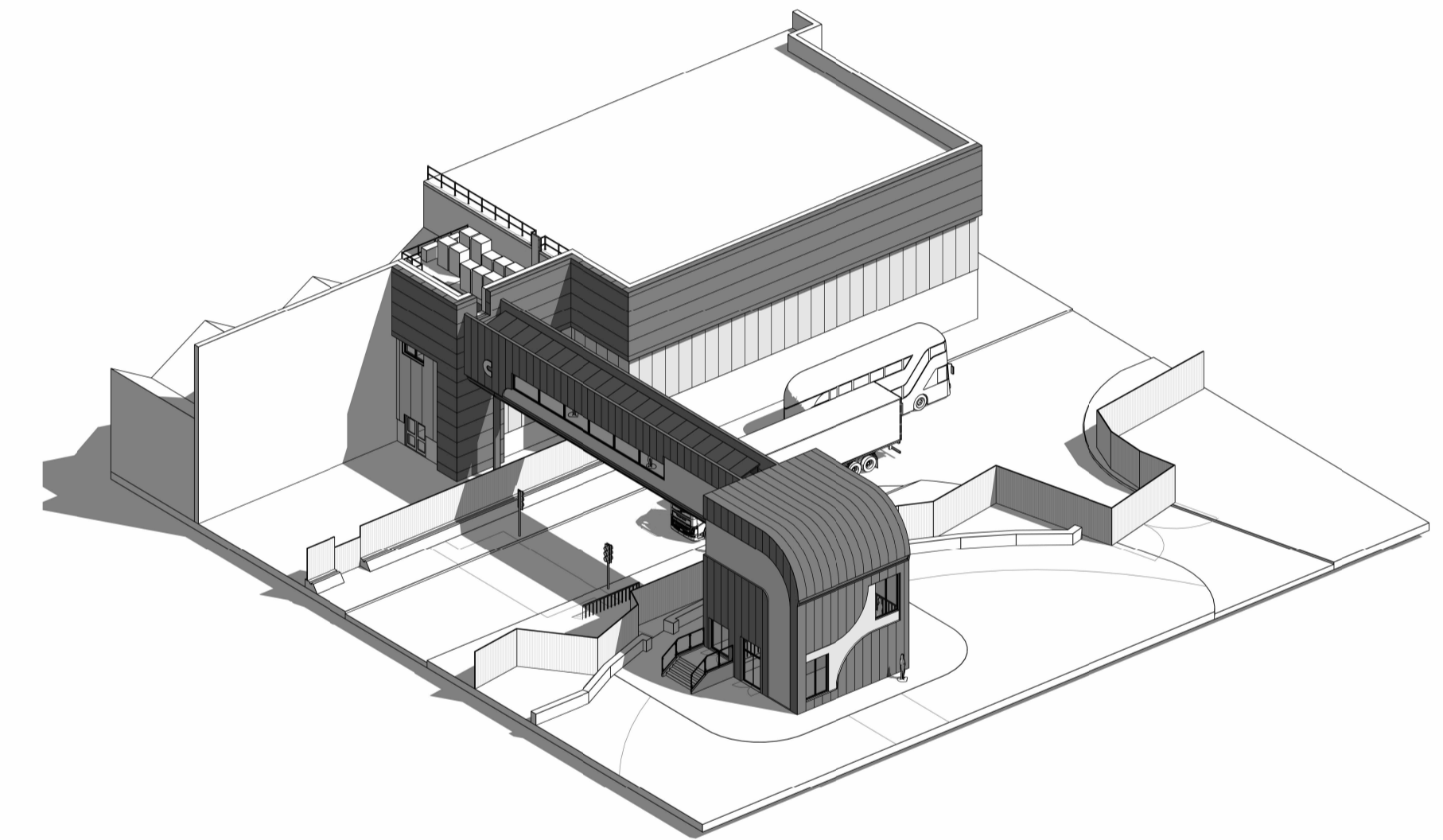
**ELEVATION 1 - AS PROPOSED**

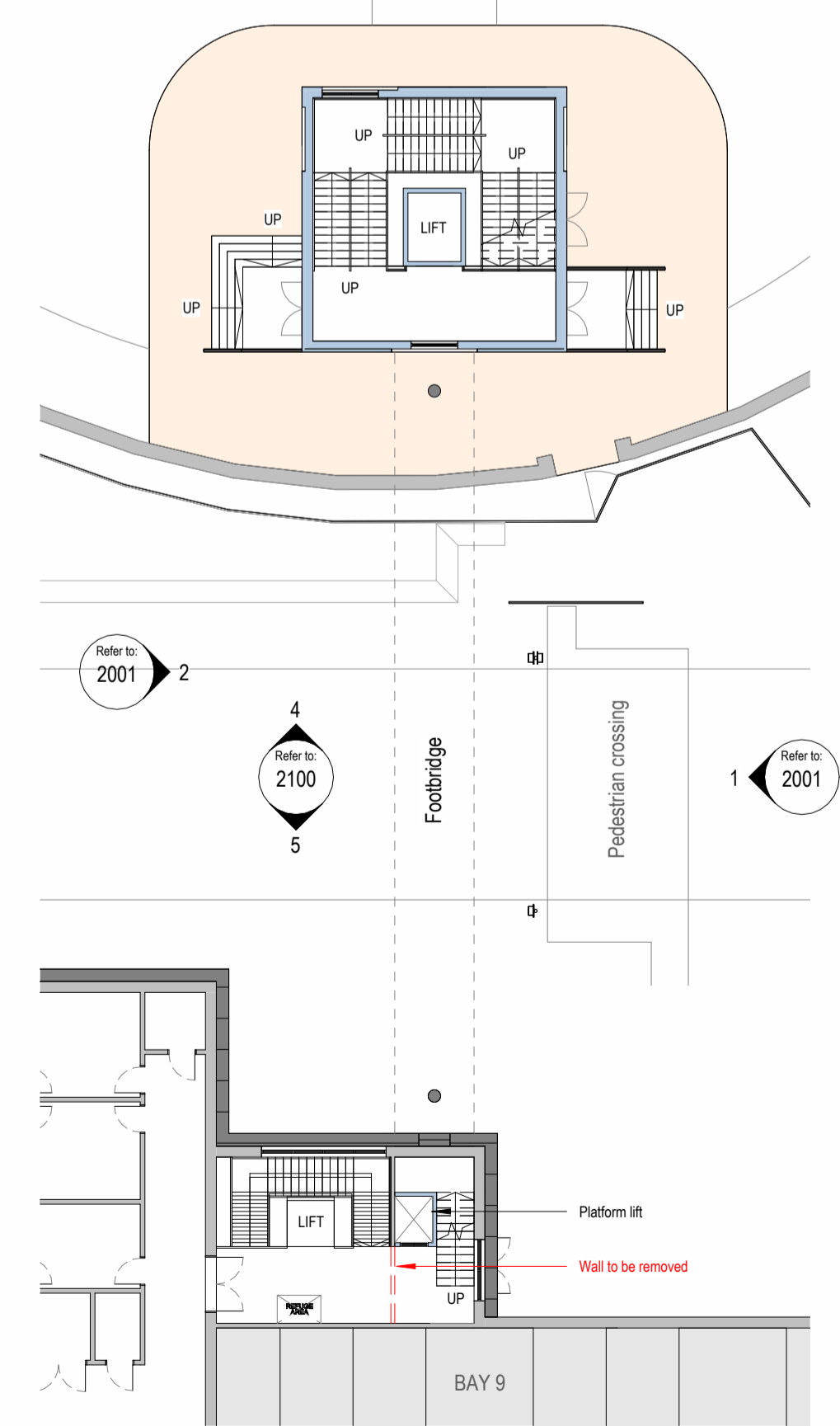
**GROUND FLOOR - AS PROPOSED**

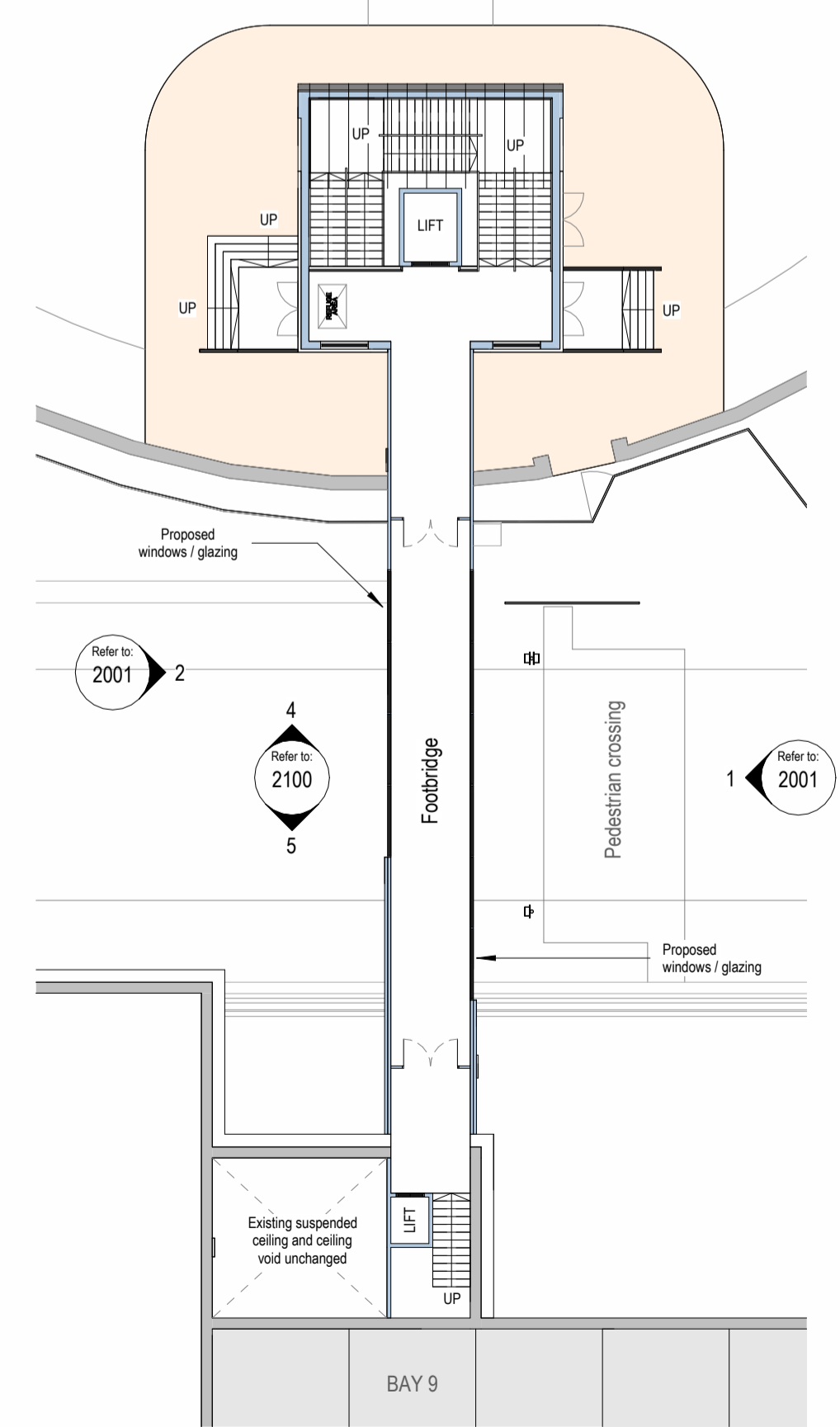

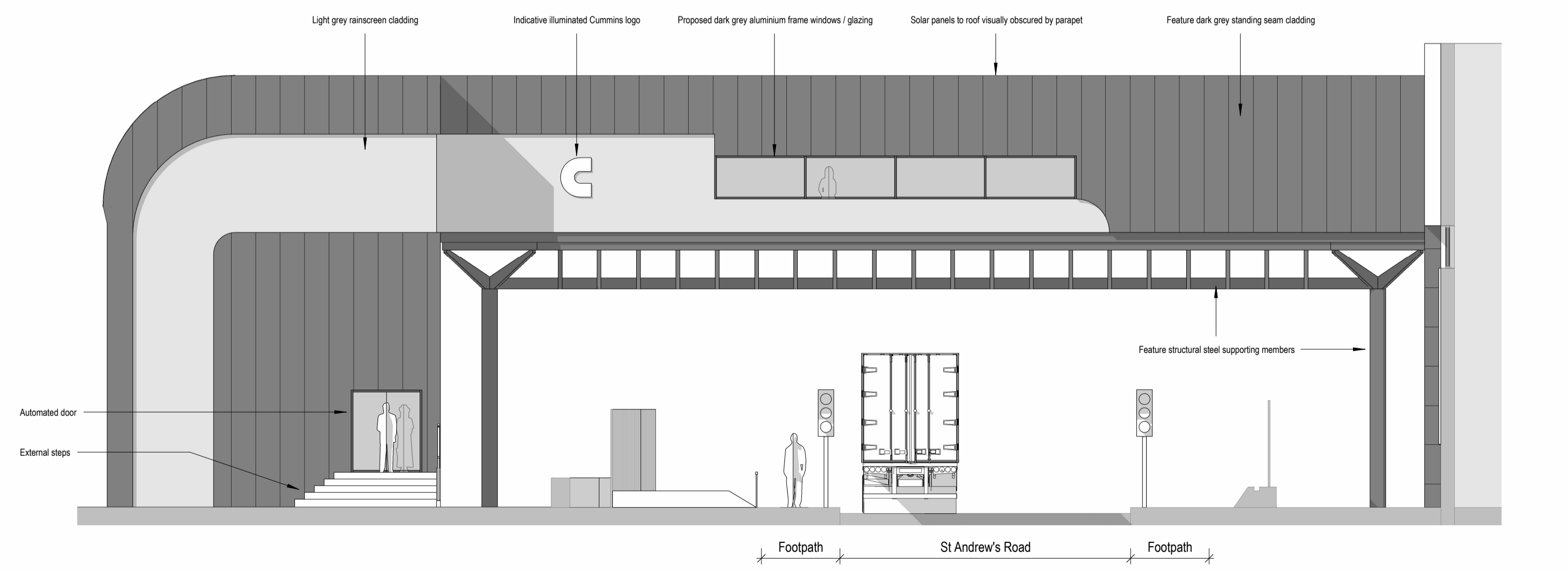
**3D VIEW**



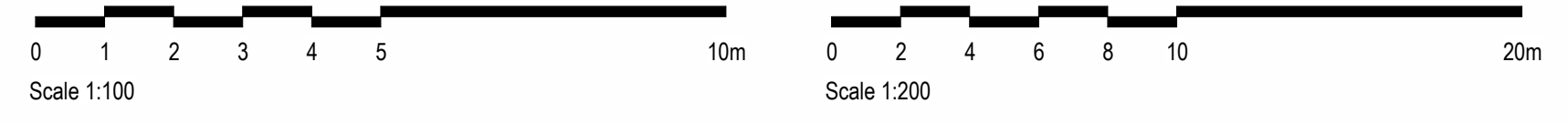
**FIRST FLOOR - AS PROPOSED**
