Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Oak (1090) - Deadwood greater than 30mm in diameter in crown, open cavity on stem close to exceeding critical limit. Fell to ground level or fell to create standing monolith of 8-9m to remove risk to public safety given its close proximity to public footpath.

Oak and White Willows (1092) - Deadwood greater than 30mm diameter in crown and dead trees. Pollard the willows in the group to remove risk to public safety given its proximity to a public right of way.

Ash (1093) - Deadwood greater than 30mm diameter in crown. Remove deadwood greater than 30mm in diameter over the path to remove risk to public safety given its proximity to a public right of way.

Mixed species group containing Silver Birch, Oak, Hawthorns and Hollies (1096) - Deadwood greater than 30mm in diameter in crown and dead trees. Remove deadwood greater than 30mm in diameter where it extends over path and remove dead trees within 10m of the public footpath to South of the wood to remove risk to public safety given proximity to the public footpath.

Oak (1097) - Deadwood greater than 30mm in diameter in crown, open cavity in the stem close to exceeding critical limit. Fell to ground level or fell to create standing monolith of 5-6m to remove risk to public safety given its proximity to public footpath.

Mixed species group containing Silver Birch, Oak, Hawthorns and Holly (1098) - Deadwood greater than 30mm in diameter in the crown and dead trees. Remove deadwood greater than 30mm in diameter where trees extend over the path, reduce dead trees within 10m of paths to create 5m tall monoliths to remove threat to public safety given close proximity to public footpath.

Oak (1099) - Deadwood greater than 30mm in diameter in crown, open cavity on stem close to exceeding critical limit. Fell to ground level or fell to create standing monolith of 5-6m to remove risk to public safety given its close proximity to public footpath.

Oak (1100) - Deadwood greater than 30mm in diameter in crown, open cavity on stem close to exceeding critical limit. Fell to ground level or fell to create standing monolith of 5-6m to remove risk to public safety given its close proximity to public footpath.

Oak (1101) - Broken/hanging branches in crown. Remove broken/damaged branches and make branches on the ground safe to remove risk to public safety given its close proximity to a public footpath.

Oak (1102) - Deadwood greater than 30mm in diameter in crown, open cavity on stem close to exceeding critical limit. Fell to ground level or fell to create a standing monolith of 4-5m to remove risk to public safety given its close proximity to public footpath.

Mixed species group containing Silver Birch, Oaks, Hawthorns and Hollies (1110) - Deadwood greater than 30mm in diameter in the crown and dead trees. Remove deadwood greater than 30mm in diameter where trees extend over the path, reduce dead trees within 10m of paths to create 5m tall monoliths to public safety as trees adjacent to public footpath

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

e.g. Oak (T3) – Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
