External walls are of a durable one-piece construction with high-performance, low-maintenance plastisol steel cladding to offer protection against fire, extreme weather and accidental damage. Internally, the walls are of vinyl faced gypsum wallboard, providing an impact resistant, wipe-clean finish.

Outstanding insulation is provided by patented construction of the roof. The roof deck is of one-piece construction and is impact resistant. It is covered with solar-reflective, profiled plastisol steel to reduce heat gain. Internally the ceiling is designed to prevent condensation problems. It is covered by polyester steel for low-maintenance finish.

The windows have a distinctive radius cornered, powered-coated aluminium frames and are top hung. Tinted glazing reduces solar glare and a thermal break prevents condensation problems. Draughts are minimised by effective weather seals and double-glazing is available as an option. Duplex buildings also offer protection against theft and vandalism, with a wide range of security options.
