The proposal is exempt as a de minimis development for the following reasons:

- o The railings / fencing and CCTV poles do not affect a priority habitat area (<https://naturalengland-defra.opendata.arcgis.com/datasets/Defra::priority-habitats-inventory-england/explore?location=53.611847%2C-1.720191%2C17.80>)
- o The proposed works do not affect any linear habitats (the railing is along the end of a lawn - no hedgerows or verges affected)
- o The installation of the railing / fence and CCTV poles is less than 25m² in area. I calculate that the total area of the proposal would be no more than 15m² with a generous buffer allowance. This allows for a 64m long railing with a width of 100mm (to include a buffer as the railings are only 40mm wide), and the three 76mm diameter poles with additional area added for cable connections.
