The site currently consists of 100% hard surfaces with no ecological value, which is less than the 25sqm threshold. Recognizing the presence of bats in the area, the design includes bat boxes to mitigate any potential impact on local wildlife and also includes a sparrow terrace. The proposal includes soft landscaping with native plant species to increase bio-diversity.
