## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Common Lime: Crown reduction of 4m in height and proportionally in spread. Crown lift to 4m. Tree is overhanging adjacent dwelling dropping leaves, sap and debris onto the roof and gutters. The low crown is a physical obstacle requiring lifting so that people can pass beneath the canopy and use the patio space surrounding. The canopy also now blocks the owner's sky dish and prevents signal.

T2 Sycamore: Reduce back laterally from neighbour's garden (to the south) by 1.5m from branch tips. Neighbour has complained about overhanging branches and also parks their car beneath the canopy. The car is covered with debris and sap and the tree owners are receiving continual complaints.

T5 Horse chestnut: Crown lift to 6m over road. Reduce canopy back from roadside (east) by 2m from branch tips. The owners have received letters from truck drivers complaining about conflicts between vehicles and the canopy which is already circa. 4.5m high above the road. Vehicle strikes also observed from busses that drive through this area. A crown lift and slight reduction to the east is required to clear the roadside and reduce the owner's liability.

T6: Common lime: Crown lift to 4m. Remove deadwood. This tree has a low crown and epicormic growth close to ground level. The tree owner is hitting these branches when she backs her car out of the garage. Low canopy prevents walking around the area beneath the canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
