Mature sycamore that overhangs onto applicants property, the applicant has planted two young oak trees one of which is heavily shaded (see attached photos) and will not be able to fully establish due to the sycamore. I have recommended crown lifting the sycamore to provide at least 5-6 metres ground clearance and enough clearance to allow the oak to establish.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
