The tree is a common lime and now blocks most light from the lounge and a bedroom of the property. It has also crowded out growth of a tree on the pavement. It blocks the house drainage and also drops differing matter during the year on the pavement and drive. It also raises the tarmac on the adjoining house drive.

I would like to replace this tree with a more suitable tree type for this position.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
