Removal of the lime tree by instructing a tree surgeon. We will plant two replacements either side of the current tree. We suggest two maple trees, as these do not grow as tall. The new maple trees will start off as 120-150cm tall.

The lime tree needs to be removed as it borders the access road to our car park. Branches have previously fallen off on to peoples cars and we are concerned that this could cause physical damage to our staff. Additionally, the access road is used as a short cut to Manchester Road and has a heavy footfall of people throughout the day. This includes dog walkers, elderly people and school children. It therefore poses a risk to the general public as well as our staff members.

Branches from the tree have also fallen off onto our office building roof, as the tree has grown so large that it now overhangs the roof of the building. We are concerned that serious damage to the building could be caused if the tree is allowed to grow further. This poses a risk to those who work inside the building.

The branches are also obstructing the windows in the upstairs office. This is causing tree sap to seep onto the windows and we are unable to have a window cleaner clean this off as it cannot be accessed. This is therefore damaging the building.

Additionally, staff are unable to properly open the windows as the branches are in the way. We have a duty of care to our staff to adequately ventilate the office space and ensure that it is a comfortable temperature, we are currently unable to do this properly, as the windows cannot fully open.

Furthermore, some staff have complained of severe allergies/hay fever as a result of the tree pollen entering the office through the windows when they are partly opened (owing to the obstruction).

Images of the tree from the outside and inside of the building are included in this application.

Question 8 states that we require written evidence regarding damage to property though we do not have this. The branches fell on to and damaged employees cars, the branches fell onto the roof and this was cleared up by a member of staff when they were clearing out the gutters. We unfortunately do not have images of this. Though the general images sent show how large the tree is and that it is protruding into the building and the access road.
