Hi Sohaib

As discussed last week the stone supplier has ceased trading and we are unable to obtain the current stone.

This leads us to now investigate alternative methods of completing the site. Rick and the team have discussed the render (which will be required on some of the plots that have already had stonework started).

On some of the others (plots to be confirmed) but potentially 1-5 and 19-22 we may be able to secure NEWLAY stone to build these.

At this stage we need to be careful about committing to the finish product as we need Yorkshire housing to confirm and we are yet to secure the newlay, but can you issue the below to the planner and enquire if the previous agreed Newlay stone is still an approved product should we be able to secure it for a limited number of plots.
