In this application we are applying for 2 sets of works to undertake. Firstly the owner would like to remove 2 branches that are protruding towards their property that are either touching or could cause potential risk going forward. Secondly the neighbour would like remove overhanging branches that affect his land on the opposite side of the tree. The work the neighbour is wanting doing has been previously undertaken and is epicormic growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
