We have been instructed by the resident of 18 Teasel Close to submit this application for the removal of two Sycamore Trees.

The removal of two Sycamore trees subject to TPO is required.
The trees are both suffering with substantial decay at their respective bases.

T1 (noted on the map provided) has evidence of previous wounds which have not entirely healed. This has caused rot pockets, decreasing the strength and stability of the tree. The root system is also causing damage to a nearby outbuilding. The tree is now touching the aforementioned outbuilding, as shown via the photographs, it is therefore anticipated that the continuing growth of T1 will result greater damage to the building.

T2 is severely leaning towards a neighbouring property. Both T1 and T2 are in close proximity of one another. T1 is the maturer tree, which has caused T2 to alter its natural path to maximise its exposure to light. This has also caused an unequal canopy growth, with the majority of the canopy growth being on the Eastern side. The imbalance in growth and increased weight on one side, is adding to the risk of T2 failing at the base and collapsing into the neighbouring property.

The applicant has confirmed they are open to the replanting of a like-species in a more suitable position.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
