Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Large sycamore tree in rear garden, at the bottom left. We have lived at this property for over 40 years and this tree is probably well over 100 years but until the night of the 22nd August 2024, it has caused us no real problems with only the occasional large twig falling onto the garden. However, that night (we were away on holiday) 5 large branches came off the tree, 3 landing in our neighbours garden (no. 28) and the other 2 in ours (photos). They had landed like spears at the side of our corner arbour and each measured 3.5 metres overall. The ones falling next door had already been removed by the time we returned home but were all of a similar size and one had reached as far as the back door of their house.

Upon our return, we immediately contacted Peter Sharp of Sharps Tree Services, who has worked on this tree over the years, as permitted, who came out to look at the tree. All the branches have come from very high up but what concerns him was the large hole about 7 feet up into which he inserted his hand to remove debris of dead wood and peaty like substance. He told us the tree was decaying here, above and below the hole (which is where a branch had been removed 40+ years ago - not in our occupation).

Because of the amount of branches the tree had discarded and their size - any one of them could have caused a fatality, if they had hit someone, we are now extremely concerned for our future safety. We spend a lot of time maintaining and enjoying our garden, and our grandchildren play out regularly, but we now have the overriding concern that further branches will fall, particularly as it is often windy. We were lucky that no damage to property was caused on this occasion, but if the whole tree fell I hate to think how much damage it would cause. I am therefore requesting permission to remove this tree as it is now unsafe, although I will happily replace it with a species as recommended by you.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
