87/91/t1 (See plan identified in red T2) Horse Chestnut tree to be removed due to being classed as a dangerous tree - identified in report produced and submitted along with planning permissions. Please see 'Tree Survey - Appendix 1' Ref 230329

87/91/t2 (See plan identified in green T1) Lime tree, to carryout work to ensure continued good health of the tree and maintain overhanging branches to adjacent home. Crown lifting to approximately 4 metres above ground level, to prevent obstruction of neighbouring driveway and providing sufficient clearance to surrounding properties. Partial crown reduction to remove lower overhanging branches, preventing branches contacting surrounding roof and cars.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
