SECTION 38 DRAINAGE NOTES

ALL GULLIES TO BE PROTECTED FROM SILT DURING THE CONSTRUCTION PROCESS WITH A LAYER OF HESSAN SHEETING PLACED UNDER THE GULLY GRATING. THE HESSAN SHALL BE CLEANED AND MAINTAINED THROUGHOUT THE CONSTRUCTION PERIOD.

ALL ADAPTABLE HIGHWAY DRAINAGE (INCLUDING MANHOLES, GULLIES AND GULLY CONNECTIONS) IS TO BE CONSTRUCTED IN ACCORDANCE WITH SEWERS FOR ADOPTION - 6TH EDITION AND UNITED UTILITIES STANDARD & TYPICAL DETAILS.

GRANULAR SUB-BASE TYPE 1 OR TYPE 2 MATERIAL IS REQUIRED TO ALL SEWER AND GULLY CONNECTION TRENCHES BENEATH THE ADAPTABLE HIGHWAY.
