On the basis of the attached report, my client is being advised to clear the trees from his land, to avoid them falling onto the highway and to discourage the extensive fly tipping the land is attracting. The removal will involve partial closure of the highway and estimates recurrently being requested for this work. It is proposed to seed the cleared land with grass and wild flowers.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
