Following a substantial roof leak which caused severe damage to all floor levels, we were advised to undertake immediate remedial works to prevent further deterioration of the asset. This involved the removal of the former tenants fixtures and fittings and the hack of plaster to walls and ceilings. As a part of this, further asbestos was identified by our internal team and it was determined that removal was necessary. The asbestos was located within boxing and clad to the stairs. Since that point, even more asbestos has been identified which will need removal.

Future work proposals, if consent is granted, includes:

- Replaster walls and ceiling to downstairs rooms
- Form new toilet and storeroom (see supporting plan document)
- Fit door at top of stairs to secure upstairs
- Paint the stairs and down stairs rooms
