Following consultation with local tree surgeon Simon Sharp we have identified 4 of the trees require work to ensure safety to people and premises. I called him following a large fracture to the Large sycamore which is our primary concern.

Unfortunately I cannot identify any with individual TPO numbers.

1. LARGE SYCAMORE located close to our drive and the garage belonging to 45A Colders Lane. This tree recently lost a branch in bad weather. It is 2 trunks which have merged together to form one very large, very old (150 years?) tree. The union leaks and sometimes big fungi grow. The canopy reaches over our roof. Sharps recommend a crown thin by 30% and crown lift of 5 metres also removal of any lateral branches. It appears healthy however there is a hole in the trunk nearest the house, and the join is a concern.

2. OAK tree appears healthy but unfortunately has grown toward the house so leans at an angle. Sharps have recommended removal of lateral branches

2. OAK TREE appears healthy but unfortunately has grown toward the house so leans at an angle. Sharps have recommended removal of lateral branches growing on the side nearest the house also crown thin 30% and crown lift of 5 metres. Located next to our house (see sketch)

3. & 4. LARGE SYCAMORES. Located top of garden near shed (see sketch). These two trees are generally healthy. They are very large and Sharps have also suggested crown thin 30% and crown lift 5 metres.
