Two Willow trees located on council land

Tree One to the top right of the garden area which has previously been damaged when a tree from the council land fell over and landed on the customers land

We would like to pollard this tree to a safe height roughly Half its current height

Tree two willow is to the right over the next doors neighbours garden

This one the customer would again like to pollard to half its height.

Ivy would be stripped off both trees.

This is due to the customer concern that these trees will fall over like one did recently and so she wants to reduce that risk by having the trees vastly reduced.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
