The tree is a Fully mature Ash tree that has various bracket fungus evident in the crown and a fairly substantial basal cavity. With the tree close to buildings and overhanging the applicants garden area they are wanting to remove the tree before any potential failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
